Deposit:

The Party has agreed to deposit an interest free deposit of Rs. 10,000/- (Rupees Ten Thousand only)

Relationship between parties hereto:

The relationship between Jyoti and the Party is on the principal to principal basis and this agreement is not to be construed as an agency or proprietorship of any kind between the parties hereto.

The Party will be responsible:

- To promote and safeguard the marketing interest of Jyoti make AC Motors
- The Party will also be responsible for keeping a close tract of various tenders/enquiries that may be floated from time to time for AC Motors in order to ensure that they quote against the tenders / enquiries in time. They will be generating enquiries for the products covered under this agreement.
- The Party agrees to keep in his employment necessary technical staff capable of marketing / servicing AC Motors.

- Under the terms of this agreement, The Party agrees to maintain at its cost a proper and well kept sales office. The party will take appropriate Sales Promotional efforts including advertising direct mail publicity, Seminars and activities carried out by The Party and expenses incurred in each contract year shall be furnished to Jyoti on half yearly basis. The party agrees to pay on demand its contribution as may be mutually agreed, towards Jyoti's overall advertising and Publicity efforts.
- The Party will be responsible for all losses incurred by Jyoti on account of refusal or non-payment of amount payable for goods sent to The Party or to their clients. The Party shall be responsible to make payment to Jyoti in such cases.
- The Party agrees to keep a reasonable stock of the products covered in this Agreement and also spare parts thereof as may be necessary.
- The Party shall treat as strictly confidential all sales and engineering data received by them under the terms of this agreement. Those sales and engineering data shall, however, remain the exclusive property of Jyoti.

Company's responsibility:

- Jyoti shall provide the required technical data/information to the Party for preparing the quotations in time and for getting the orders.
- Jyoti shall provide sufficient numbers Sales promotion brochures / product catalogues to Party every year. However, the additional quantities if required will be on chargeable basis.
- Jyoti shall supply the material within the mutually agreed delivery period.
- In the event of Jyoti quoting directly against enquiries generated by Party or where Jyoti specifically request party to follow up a particular quotation, and if such quotation materializes into an order, party will be entitled to get commission on FOR Vadodara prices exclusive of taxes and duties etc. of the order value. The commission percentage will be decided on case to case basis before quoting to the customer.

Termination & validity of agreement

Either party to the Agreement can terminate the Agreement by giving to the other party two Calendar months' prior notice in writing.
